European Standard EN 1504-2 (Products and systems for the protection and repair of concrete structures – Definitions, requirements, quality control and evaluation of conformity – Part 2: Surface protection systems for concrete). This standard specifies the requirements for the identification, performance (including durability aspects, safety and evaluation of conformity of products and systems to be used for the surface protection of concrete, to increase the durability of concrete and reinforced concrete structures, as well as for new concrete and maintenance and repair work. The surface protective methods covered by this document are: hydrophobic impregnation; impregnation; coating.

Flooring systems in buildings which are not intended to protect or reinstate the integrity of the concrete structure are standardised in EN 13813. When products and systems complying with this standard are used in flooring applications that involve substantial mechanical loading, they should also satisfy the requirements of EN 13813.

The clauses of this European standard in Annex ZA meet the requirements of the Mandate given under the Construction Product Directive (89/106/EC).
